## OHSLA Spring Meeting Summary

The OHSLA Spring meeting was held on Monday, March 31, 2003 at the OSU Prior Health Sciences Library. The Business Meeting was held on the Fifth Floor in the Medical Heritage Center, and the program took place in the Fourth Floor Classroom.

Margaret (Peg) Allen presented a CE program on "Finding the Best Evidence to Meet Nursing Information Needs," which awarded the participants 4 MLA contact hours. Julie McDaniel and Linda DeMuro were Program Committee Members. Forty-five people were registered for the meeting, at a fee of \$50 each. Peg Allen's fee and travel expenses were reimbursed in the amount of \$1000.

Thirty evaluations of the meeting were submitted. The evaluations rated Ms. Allen's presentation in four areas, gathered demographic data on the registrants and solicited ideas for future meeting topics. Sixty-seven percent, or approximately two-thirds, of those submitting evaluations were from hospital libraries and 30% were from academic libraries; three percent listed their institution as "other". Geographically, attendees were evenly divided between Northeast Ohio (33%) and Central Ohio (33%). Ten percent were from Southwest Ohio and 13% were from the Northwest part of the state. The remaining attendees came from Southeast Ohio or "other". Ms. Allen's expertise and the content of her presentation were very highly rated, with over 90% of registrants marking her as either excellent or very good in these areas.

Suggestions for future meeting topics were: new technology in libraries, grant writing, statistical information, copyright, overview of Cochrane databases, PDAs, bioterrorism resources, genomics/NCBI, IRB/research ethics, and informatics.

Cold Spring Harbor Laboratories, Dana Farber Cancer Institute, Georgetown, Harvard, and all the University of California sites. SPARC, the Scholarly Publishing and Academic Resources Coalition, has partnered with BioMed Central in its commitment to open access publishing. ## Is Your Library "LinkedOut" Yet?

"My" library and computer laboratory at Doctors Hospital of Stark County are open "24/7". But I am only there 25 hours each week. So, even when I am not there, how can I let my library users know that the articles they need are available through the library's online subscriptions or can be found in the print journal stacks? LinkOut is the answer!

I confess that I hesitated quite a while before signing up for a LinkOut account. It sounded like a lot of work and besides, I had no idea how to make the needed icons. But once I signed up, I was pleasantly surprised by how easy it was to link the SERHOLD information to PubMed and to tag the online journal subscriptions. I asked my buddy Pat in the public relations department to make an icon for me (he seemed happy to try out his new PhotoShop skills), but I didn't actually need to make my own icon since NLM provides "generic" icons for those of us with minimal computer graphics skills.

To find out all you need to do to know to set up LinkOut for your library, check out the "Library LinkOut Survival Guide" at <http://nmlm.gov/libinfo/ejournals/linkout/> for links to helpful resources. I particularly recommend the LinkOut presentation from the New England Region NN/LM by Mark Goldstein.

Currently there are 36 Ohio medical libraries using LinkOut. How about adding your library to the list?
