Summary of the OHSLA Fall Meeting

The OHSLA Fall Meeting was held on Friday, October 19, 2001 at the Wright State University Nutter Center in Dayton. The Program theme was geriatric resources and our speakers were Marshall B. Kapp, Director of Wright State University's Office of Geriatric Medicine and Gerontology and Ruey L. Rodman, Head of Access Services at Ohio State University's Health Sciences Library. The Fall 2001 Program Committee members were Linda DeMuro and Susan Wehmeyer.

Thirty two individuals registered for the meeting which began with a continental breakfast. Dr. Kapp's presentation, "Resources and Critical Issues in Aging," began at 10:30 and ended at noon. The PowerPoint presentation and handouts generated a great number of questions from the attendees who, on an overall basis, rated the program "excellent." The Business Meet-

ing was conducted by President Linda Bunyan at the luncheon which was scheduled from 12:00 noon to 1:45 p.m.

The afternoon speaker, Ruey Rodman, presented, "The S.A.G.E. Project, a Library Model to Support Distance Education Instruction at the Ohio State University," from 1:45 – 2:30 p.m. This program detailed library support for a distance geriatric education program. Ms. Rodman's afternoon PowerPoint presentation and handouts were also ranked "excellent." The meeting concluded with a wrap up and evaluation from 2:30 to 2:45 p.m.

The Program Committee Chair sent thank you letters to the two speakers and members of the Program Committee. An honorarium of \$200.00 was enclosed with Marshall Kapp's letter. Fourteen evaluations of the meeting were turned in. The

evaluations rated each speaker individually in five areas, gathered demographic data on the attendees and solicited ideas for future meeting topics. The evaluations showed that 50% of those attending were from hospitals, 43% were from academic institutions, and 7% were from government agencies. In terms of geographic locations, 36% were from Southwest Ohio, 29% from Central Ohio, 21% from Northeast Ohio and 14% from Northwest Ohio.

Program suggestions for the Spring Meeting included: PDA's (mentioned 4 times); nursing resources (mentioned twice); PubMed (mentioned twice).

OHSLA Bylaws Revisions Proposed

The OHSLA Executive Committee is proposing a number of revisions to the current bylaws, primarily to clarify items. The proposed revisions are: (1) the term of office for officers and when they are elected (Article IV, Section 3), (2) who the non-voting members are serving on the Executive Committee (Article V, Section 1), (3) the number of people needed to serve on standing committees (Article V, Section 2, Parts C, D, and E), (4) how elections are handled (Article V, Section 2, Part C) and (5) who appoints the Communications and Archive Committee Chairs (Article V, Section 2, Parts D and E). Article IV, Section 1 is basically a reordering of the officers and addition of the phrase "immediate Past-President". This revision is proposed to reflect the change in wording of Article IV, Section 3 (listed above). The membership will vote on these revisions at the Spring Meeting in Columbus. Please read the insert detailing the proposed revisions. GMR Announces New Subcontract in Ohio

The NN/LM Greater Midwest Region is pleased to announce its first Public Health Network Models Subcontract. This subcontract is jointly funded by the GMR and the Centers for Disease Control and Prevention (CDC).

Recipient: Ohio State University Prior Health Sciences Library
Project Directors: Mary Sprague and Pam Bradigan
Title: Ohio Appalachian Public Health Information Literacy Training.
Amount: \$49,980

Description: The primary goal of this project is to provide public health workers in selected Ohio Appalachian counties with the skills, access, on-going user support, and information services relative to their practice, including the use of CDC, NLM and NN/LM information resources. Additionally, the project aims to increase consumer awareness of public health issues by partnering OSU Extension faculty and local health department staff to create web-based public information content. The Ohio State University Prior Health Sciences Library, OSU Extension, the Ohio Department of Health, and Region 5-A of the Ohio Area Health Education Centers (AHEC) are partnering in this project.

The project will survey public health workers in all twenty-nine Appalachian counties to determine their information literacy training needs. From among survey respondents, four local health departments and their respective OSU Extension offices will be selected to participate in a pilot project to develop educational modules guided by training needs identified in the survey. Pilot project participants will also work with OSU faculty to develop public health content for local web sites. Funding and time will determine expansion of the program to the remaining 25 counties.

OHSLA SPRING MEETING OFFERS CONTINUING EDUCATION CHOICE, REGISTER NOW – SPACE IS LIMITED!!

The OHSLA Spring Meeting will be held on Friday, April 26, at The Ohio State University Prior Health Sciences Library. In addition to our regular business meeting, registrants can attend one of two available MLA-approved continuing education courses. Each course will count for 3.5 MLA CE credit hours.

Beth G. Carlin (Exhibits and Outreach Coordinator for the NNLM Greater Midwest Region) will present, “Making PubMed Work for You.” This class is intended to hone basic searching techniques and the ability to develop search strategies that take advantage of the PubMed interface to MEDLINE. Topics will include using MeSH and search qualifiers, limiting search results, refining searches, SDI searching, and links. The course will provide an in-depth view of the system and registrants will have hands-on opportunities to practice search techniques. Diane Kovacs (Kovacs Consulting) will present “How to Find Medical Information on the Internet for Healthcare Professionals and Consumers.” In this class attendees will learn how to search for and evaluate health and medical information on the Internet. Web search tools that are specialized for health and medical research will be highlighted. Participants will have access to web-based instructional materials after the workshop.

The Spring Meeting provides a great opportunity to enroll in a continuing education course at a very reasonable price.
