OHSLA Fall Meeting Summary

The fall meeting took place October 27, 2007 at the Nutter Center located at Wright State University. In the morning session, Dr. Jan Belcher, Associate Professor Wright State University, presented "Evidence Based Practice and Magnet Recognition." The afternoon program was a round table discussion among the attendees regarding magnet nursing, library resources, and evidence based nursing.



The program was well attended and received. Thirty members attended and filled out surveys.

The program was rated "very good" with an average of 4 or higher on a five point scale. The lowest score was the value of handouts which were unfortunately not included in the



meeting packet. The afternoon session averaged a rating of good. While the participants enjoyed the afternoon session there were some that would have preferred to have a few more facilitators.

The geographic regions of attendees of the 30 people were: Southwestern Ohio -10 or 30%, Central Ohio -7 or 23%, Northeast Ohio -4 or 13%, Northwest Ohio -3 or 10%, other regions -1, or 3%. Five people did not indicate what geographic region they were from. The program was well attended by both hospital (15) and academic medical librarians (10).

Work with OSMA

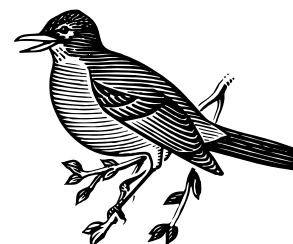
Committee members have been in contact with the Ohio State Medical Association about establishing use of the

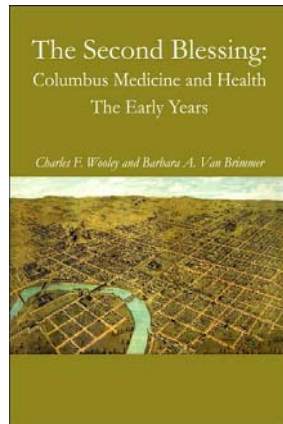


The Second Blessing: Columbus Medicine and Health The Early Years

“The Second Blessing” is a unique regional history describing the origins of medicine, health, health care, medical education, and public health in metropolitan Columbus, Franklin County, and Central Ohio. Beginning with the frontier settlements in central Ohio, the narrative extends through Statehood in 1803, and continues and expands throughout the nineteenth century, culminating with the establishment of The Ohio State University College of Medicine in 1914.



dynamic regional history, central to the American experience with origins in the early days of white settlement.

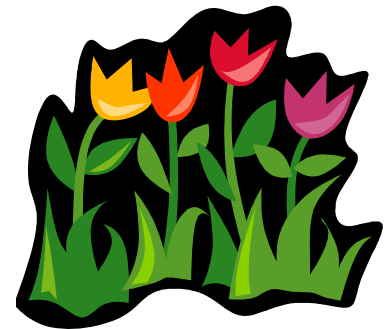
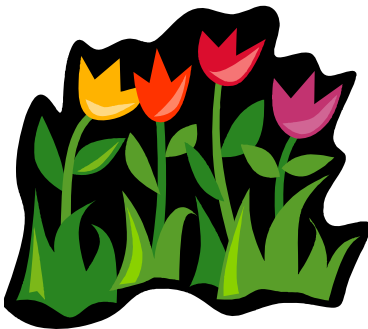
Filled with rich illustrations, the book is the culmination of a ten-year project for its authors and the Medical Heritage Center at The Ohio State University Prior Health Sciences Library. The idea for the work came to the co-authors, Charles F. Wooley and Barbara A. Van Brimmer when assembling

collections for the newly-formed repository in 1997. The book was published due to the generous support of the Columbus Medical Association who provided a matching-grant opportunity to the Medical Heritage Center in 2002. The late Barbara A. Van Brimmer served as the Medical Heritage Center’s first curator and Charles F. Wooley served as a scholar-in-residence at the Medical Heritage Center. He is currently an affiliated scholar with the institution.

Remarkable individuals and their unique stories come to light as the authors allow readers to step back in time and view the origins of medicine and health in Columbus, Franklin County, and Central Ohio. The book’s authors discovered an extraordinary lineage of men and women who established the bases for communities and met the emerging medical and health needs of the populace as the frontier moved west and Columbus emerged from settlement to town to twentieth century metropolis.
